Storebrand Asset Management is Norway's largest private asset manager and a specialist in sustainable investing.

Rather than only applying ESG criteria to a proportion of assets, Storebrand believes sustainability must be implemented across entire portfolios. All assets are managed according to the industry-leading Storebrand Standard sustainability criteria.

Climate change poses a growing threat to our future, including the stability of our financial system¹. Global equity markets contain high carbon risk and fossil fuel exposures, meaning that traditional passive investments represent increasing unmanaged climate risks.

To address this problem, we have been managing sustainable index funds since 2005, successfully optimising portfolios to minimise climate risk and tracking error. Our funds' performance demonstrates that incorporating sustainability has not diminished returns.

INVESTMENT STRATEGY

Storebrand Global ESG Plus is a unique fossil-free global equity strategy which aims to provide long-term capital growth through a model-based portfolio of developed market equities. The fund is managed systematically and seeks to reproduce the risk and return profile of the MSCI World Index whilst excluding companies within fossil fuel related industries and with additional ESG criteria and sustainability focus.

Since inception over three years ago, the Norwegian-domiciled fund has provided index relative returns of +0.7% with 1.5% tracking error². The strategy seeks to provide a low-cost investment solution for the global climate emergency by using six key components:



DIVESTMENT

We exclude fossil fuels (>5% of sales) and companies with climate negative exposures (e.g. plastics and meat). The strategy is Parisaligned and considers climate risk across the value chain.



GREEN SOLUTIONS

We allocate 10% of the portfolio to climate solutions companies, such as renewable energy, green transport, recycling, water and energy efficiency.



LOW CARBON FOOTPRINT

We optimise the fund, using full lifecycle emissions where possible, to minimise carbon exposure. The result is a portfolio with significantly lower carbon intensity than the benchmark³.



GREEN SOLUTIONS

We allocate <10% of the portfolio to climate solutions companies, such as renewable energy, green transport, recycling, water and energy efficiency.



LOBBYING

Companies are not passive actors in climate policy. We engage with but avoid investing in those lobbying against climate action, using data from InfluenceMap and other sources.



ESG SCORE

We have developed a proprietary ESG rating system to analyse over 4,500 companies, using qualitative and quantitative assessment of sustainability risks and opportunities.

INVESTMENT STRATEGY COMMENTARY¹

- After a first quarter of index-relative underperformance due to not investing in oil & gas, the second quarter at first glance seems uneventful with performance inline with the benchmark. However, this masks large positive and negative contributions to relative returns from components of the fund's strategy.
- As in Q1, the largest negative contribution (-0.8%) came from the fossil fuel screen; -0.6% from not owning oil & gas companies and a further -0.3% from excluding fossil utilities. The MSCI Energy sector continued to rally during the quarter, outperforming the MSCI World Index by almost 30 percentage points in mid-June, before closing the quarter 13 percentage points ahead. The index weight for the GICS Energy Sector (oil & gas) is now 5.0%, up from 3.1% at year-end.
- While the fund lost 0.3% from not owning fossil utilities, it offset this by gaining 0.3% from non-fossil utilities. Most of this came from the fund's overweight in renewable electricity producers (+0.25%), with the balance (+0.05%) stemming from investments in electrical grid operators and water utilities.
- Following the Storebrand Standard exclusion list detracted 0.3% from the fund's relative return during the quarter; -0.1% from not investing in controversial weapons and -0.1% from not being exposed to tobacco companies. Both categories tend to outperform during turbulent markets, while the war in Ukraine has also improved the outlook for weapons producers.
- Until the period-end the fund followed screening lists sourced from ISS Ethix and Sustainalytics, in addition to the Storebrand Standard, covering breeches of international norms and conventions. These additional screens added 0.4% to relative performance in Q2, with nearly all of it coming from not owning Tesla. The ISS Ethix and Sustainalytics screens were removed from the fund's strategy at quarter-end (more information available on request).
- Being overweight pure-play climate solution companies added 0.1% to relative performance. Positive contributions came from Renewable Electricity and Green Transportation themes (both +0.2%). Conversely, Energy Efficiency and Recycling detracted 0.1% and 0.2%, respectively.
- The largest positive contribution to the fund's relative performance during Q2, and the effect that ensured performance in line with the benchmark despite continued, relative losses from the fossil fuels screen, was the ~90% of the fund which is invested in the broad global stock market which are neither screened companies, nor pure-play climate solutions. This part of the portfolio contributed +1.0% to relative performance during the quarter.
- Within this category, we prefer companies with attractive climate change properties, but a major driver of security selection and position sizing is the minimization of the fund's expected tracking error versus the MSCI World Index. Since the fund incurred relative losses from the investment screens, the gains from this bulk of the portfolio indicates that the fund's risk management strategy worked during Q2.
